Assessment details:

****Fitness for interview, detention, and release will need to be carried out by Merseyside Police's contracted healthcare provider Castle Rock, however, CJLT Registered Practitioner will assess fitness as part of the full mental health assessment, and will advise CRG colleagues and Police around this issue where necessary but CJL Practitioners do not DETERMINE fitness issues****

Confidentiality and role explained and Axel was able to provide examples of when I may need to breach this. He was informed that I would be asking questions relating to his arrest and acknowledged that this information would need to be shared with Police. Grace Hatton also present.

Axel reports that the student he went to see at The Range today is a male who had assaulted him a number of weeks ago. He reported that this took place at school and that the student had pulled him to the ground and hit him. This was observed by other students and Axel reports they helped him and that he has not been bullied since leaving the school. Axel reports he has found this distressing. Axel reports that he wouldn't have felt sad if he hurt him. He reports not planning to use the knife but states that he would have if the Hockey Stick did not work. Axel states that he had wrapped tissue paper around the handle to get a better grip. Axel was asked if he was planning on killing the student and he replied "I did want to kill him but I don't think I would. Ideally, I wish I did it. But they were in assembly so it wouldn't have happened". He is clear this was revenge. We explored his decision making around going to school etc and Axel reports that he has not been thinking about this for a long time but he had a random thought on Saturday. He then decided that he would book a taxi for today as he normally gets a taxi to school so this would not be out of the ordinary for him and that he would simply ask for the taxi to take him somewhere else. I asked if the male he had assaulted was involved in the original bullying and Axel stated he was not. When asked why he had assaulted him, Axel responded by saying "the Head Teacher and someone else was chasing me and I'm not going to get taken to the Police Station for nothing so I thought I would hit him". Axel reports that he liked the student he hit and had never had any problems with this boy. Axel reports it doesn't bother him that he assaulted the boy as he didn't get hurt that bad. We discussed the consequences of his action and Axel demonstrated an awareness of going to Jail, however, he appears to struggle with abstract concepts and did not fully understand what this would mean. His response was I would probably be less bored in Jail. Axel firmly denies any thoughts of harm to himself or others and has no history of this. We discussed the possibilities of him harming the male who had assaulted him. Axel reports that he is unlikely to do anything now. He reports that school is too protected. I asked what would happen if he saw this male

in the street and Axel responded by saying that he doesn't carry weapons so nothing would happen.

Traits of ASD displayed during assessment:

- Inability to form and maintain stable peer relationships
- Interaction to achieve specific goals
- No eye contact
- Use of overly complex/awkward language
- Flat voice tone
- Black and White thinking style
- Difficulties with abstract concepts
- High intellectual ability (not formally assessed)
- Increased fixation on computers i.e. playing and building
- Poor problem solving skills
- Sensory difficulties i.e. loud noise, touch, smells i.e. Church singing, noise in corridors at school, doesn't like strong smells
- Difficulty concentrating when not specifically interested in a topic – limited understanding of its relevance to his life
- Lack of empathy

Axel is a pleasant young male with a Rawandan heritage. He presents as a bright young man who displays limited understanding of the consequences of his behaviour. Whilst Axel can describe the consequences of his behaviour, his level of understanding around this remains unclear. Axel has demonstrated multiple indicators of ASD which would suggest a formal assessment is required however, due to the risk Axel currently poses to others, a Forensic CAMHS referral will be made in addition to this. This will also support management of the risk posed to him from others and possible radicalisation. At this time, Axel does not display any evidence of SMI that would warrant diversion from custody at this time however he does require some additional support and through risk management in the community. He is clear that he does not plan on trying to harm this young man again and has no history of harming others until today.

Risk assessment:

To self: SA10 low – Has no history of this and denies any current thoughts.

To Others: SA10 Medium – Axel has no history of previous offending or violent behaviour. Initial context of offence suggests this was retaliation. However, Axel's response to why he assaulted a different child is of concern along with his lack of empathy/remorse. Axel has already been excluded from school for carrying a knife and his current offence also includes the use of weapons and a direct statement that he was intending to seriously harm someone. This appears related to poor problem solving ability consistent with a possible ASD diagnosis. There are also serious concerns about Axel's use of the Internet and the nature of the information he has been accessing. Axel is currently open to the PREVENT Team around possible radicalisation.

From Others: SA10 Medium. – Axel reports previous bullying. Due to Axel's limited ability to understand relationships and vulnerability, Axel may be at risk of harm from others through the internet/radicalisation.

Care Plan:

Axel to be released into the care of his parents. Police will issue bail conditions. Social Care are fully aware of risks.

Exit plan:

Immediate risk management plan:

- Lancashire Social Care are fully involved in the case and Sergeant 3086 has informed me that they do not have concerns about him returning home this evening and will be sending out a Social worker in the morning to begin assessment of the family.
- Case has been discussed with SPR On Call Dr Anwar and Sadie Canning Dosser CJLT Operational Manager who agree that Axel does not appear to be detainable under the act but does require some further input from services. Dr Anwar advised sharing information with the family to ensure they are updated of all risks and feel they are able to keep themselves and others safe
- Axel to be released from Police Custody on bail to return to St Anne's Street Police Station at 2pm on 12.12.19
- Custody contact completed
- Discussed with Dad who is aware of the content of what Axel said. I have suggested that Axel does not attend school tomorrow to give time for agencies to create a safe and robust risk management plan of the risk he presents to others

Further risk management plan:

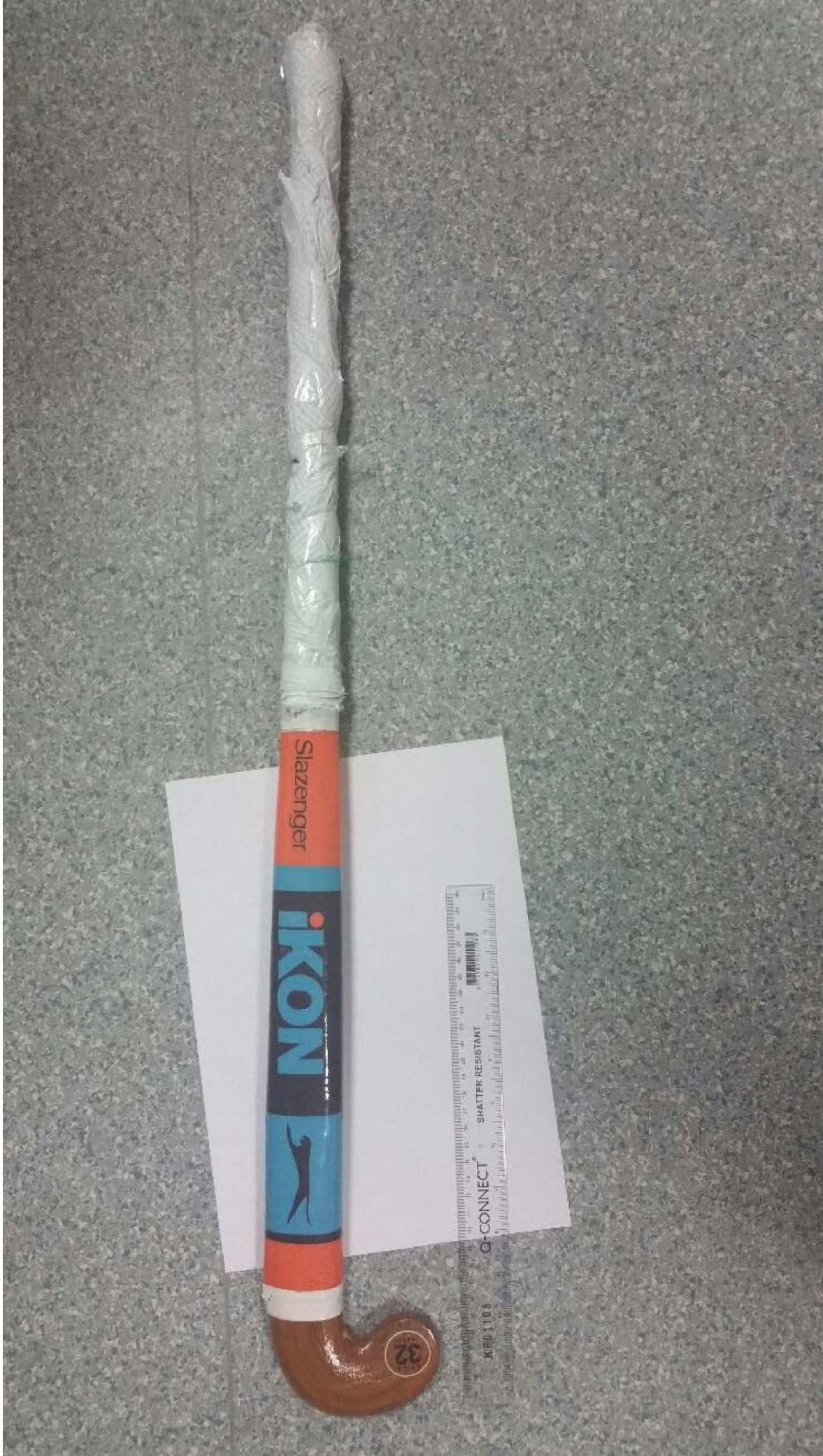
- Contact to be made with Lancashire Social Services to share assessment – Submit MARF

- Refer to Forensic CAMHS for management of offending behaviour in the context of forensic risk to others
- CJLT to obtain outcome of interview and support as required

On 11/12/2019 at approximately 0910 hrs, MICHAEL MCGARRY, the Head Teacher of the school, was conducting a year 9 assembly. His attention was drawn to the accused inside the school premises.

MCGARRY has approached AXEL and repeatedly asked the accused to leave, and began asking why he was there. The accused ignored MCGARRY and began to walk into the corridors of the school. Deputy Head Teacher Thomas DOLLY then saw the accused and MCGARRY walking down the corridor. It is alleged that the accused has then started to run, producing a hockey stick from inside his coat as he did so.

In the corridor was a group of around 6 Year 9 pupils, one of which was the aggrieved. It is alleged that the accused has swung the hockey stick above his head, and then towards the group, striking the aggrieved on his left arm. McGARRY has been able to restrain the accused from behind in a 'bear hug'. DOLLY has then taken the hockey stick from the grip of the accused. RUBAKUBANA was escorted to the head teachers office and police were called.

Whilst waiting for police to attend, the accused is said to have been very calm and insistent that his actions were not wrong. It is alleged that the accused stated that he had attended the school to look for another pupil to attack.

At 0935 hrs , Constable DODD attended the location. McGARRY explained the circumstances to the officer. RUBAKABANA stated to the officer he had a knife in his backpack. The officer searched the bag and located LD/02 - 1 X KITCHEN KNIFE. MCGARRY passed the officer exhibit LD/01 - 1 X HOCKEY STICK.

At 0945 hrs , Constable DODD cautioned and arrested RUBAKABANA on suspicion of Section 47 assault , possession of a bladed article on a school premises and possession of an offensive weapon. There was no reply to caution.

I am Police Constable 4004 CLARKE of Merseyside Police currently stationed at Marsh Lane police station in Sefton.

On Wednesday 11th December 2019 I was on uniform mobile patrol in an unmarked police vehicle in company with Constable 6359 DODD.

At 09.35 hours, I was asked via my personal radio to attend RANGE HIGH SCHOOL, FORMBY, L37 2YN in relation to a report of an expelled student causing a nuisance.

I arrived at scene and was met by the head teacher MICHAEL MCGARRY who took us to his office where he pointed out a male who I now know to be AXEL RUDAKUBANA 27.08.2006 who was sitting in the corner of the room. MCGARRY stated that RUDAKUBANA was currently expelled from the school but today he had attended in a taxi and made his way inside the building. He states that after the school assembly RUDAKUBANA was in possession of a hockey stick and was being followed around by staff. RUDAKUBANA then ran towards another student [REDACTED] lifted the hockey stick above his head and hit [REDACTED] around three times. MCGARRY passed Constable DODD a hockey stick with paper taped around the handle.

I then went to speak with [REDACTED] leaving Constable DODD with RUDAKUBANA. [REDACTED] stated that RUDAKUBANA had ran at him and hit him three times with a hockey stick causing reddening to his left arm and pain to the index and middle finger on his right hand. [REDACTED] states these injuries were caused as he put his hands up to protect his head and that there was no reason for RUDKABANA to attack him.

I returned to the head teachers office where Constable DODD had informed me he had recovered a kitchen knife from RUDAKABANA's rucksack.

At 09.45 hours, Constable DODD cautioned and arrested RUDAKABANA on suspicion of section 47 assault , possession of a bladed article on a school premises and possession of an offensive weapon, he then handcuffed RUDAKABANA.

RUDAKABANA was conveyed to ST ANNE STREET custody suite where Constable DODD relayed the circumstances of arrest to the custody sergeant who authorised his detention.

MCGARRY stated that RUDAKUBANA had been previously expelled from the school. During the school assembly today , he had attended and produced a hockey stick. On 11/12/2019 at approximately 0910 hrs , I was conducting a year 9 assembly in the school. At this point , I could see a teaching assistant was attempting to gain my attention . I sighted a male next to the staff member who I know to be AXEL RUDAKABANA 07/08/2006. AXEL has been excluded from the school due to him bringing a knife and threatening to use it . This occured in october 2019 .

I approached AXEL and began asking why he was at the school and that he was supposed to be in his new school. AXEL didnt respond to me. I advised him that he needed to come with me but at this point he ran off down the corridor. I followed asking him to stop and telling him to calm down.

At this point , I noticed a group of students walking towards Axel and myself. Axel dropped his bag and produced a hockey stick from his coat . He then approached the group and swung the stick at [REDACTED] . [REDACTED] is a student at the school and was on his way to class. AXEL hit [REDACTED] numerous times with the stick. At this point , i grabbed AXEL from behind in order to prevent him from attacking any one else and was assisted by the deputy headteacher of the school. I then escorted AXEL to my office and asked my staff to contact police.

Whilst waiting for police to attend I spoke with AXEL who was very calm and collective. He was insistant that his actions were not wrong. He stated he was looking for another boy in the school to attack.

[REDACTED] has seen a hockey stick in Axel's hand, he was carrying it hanging down towards the floor. [REDACTED] then states Axel started running towards him and lifted the hockey stick above his head. [REDACTED] initially thought Axel was messing about but as he got closer he was afraid he was going to be hit by the hockey stick so [REDACTED] lifted his arm above himself to protect his head and Axel hit his left arm with the hockey stick twice and hit the index and middle finger on [REDACTED] right hand once. This caused [REDACTED] pain.

At this point [REDACTED] noticed the headteacher of the school take hold of Axel around the body and arms from behind to stop him lashing out with the hockey stick. I was told he had been last seen towards the Maths department, all I knew he had a yellow coat and dark hair.

I went to that area and met up with the head teacher and deputy head.

The head teacher Mr McGARRY asked AXEL to stand still, he refused and kept on walking off, Mr McGARRY raised his voice and demanded Axel stand still, on the second request from the head Axel seemed to tense his body and ran off towards a T junction in the corridor, I could see he had no intention of stopping and whatever Mr McGARRY asked Axel he was just ignoring.

I observed Axel turn left, the corridor is a perfect square, I stayed static as the other staff followed Axel, as it was a perfect square I thought if he continues moving forward he will return to where I was, I was fearful of the safety of other children and put myself between other pupils, I was requesting the children go into class rooms off the corridor for safety, the square corridor has glass panels looking out onto a garden area.

I could see through the glass that Axel had carried on around the square and at the point I saw him in possession of what I thought was a baseball bat of some description, I did not see Axel in possession of the item when I was stood by him previously.

I saw him raise the item over his right shoulder and swing it on at least two occasions towards someone as I could see the arm of another person, the arm was a blazer so I formed the opinion it must have been another child, I'm not sure who this was. I later found out that Axel had assaulted [REDACTED] a full time student at the School

I stopped other children in the corridor and sent the children the opposite way, away from the danger, I turned to assist and as I did so I saw Axel being restrained by the head teacher Mr McGARRY, Mr McGARRY called for me to call the Police which I did.

Axel was then restrained by staff until the Police arrived

I had no further dealings with this matter.

The whole incident did not last long, only a few minutes from the point of being made aware of the incident to Axel being restrained, the distance between myself and Axel was at one point very close, I was stood near to him when Mr McGARRY was giving instructions towards Axel to stand still. Visibility was fine as the School corridor is well lit however my view of the incident was obscured when I stood still in order to prevent Axel escaping as my intention was to

expressing his intention to use it. This male, therefore, was trespassing and I was asked to investigate. I was informed that the school office staff had not been able to contact the Head Teacher, Michael McGARRY, as he was conducting an assembly.

I then went downstairs and into the main part of the school and on to the languages corridor on the ground floor. A number of staff members told me that RUDAKUBANA had been sighted on school grounds. I therefore continued down the corridor towards the dining room, where I sighted RUDAKUBANA walking fast towards me, and I then saw Michael McGARRY walking closely behind him. I chose not to intervene at this point as I did not know the full circumstances of what was going on, so I joined Michael in following RUDAKUBANA down the corridor. Michael was repeatedly asking him to stop, and not to go any further into the school. He completely ignored these instructions and continued walking with purpose into the languages corridor, where I had just come from.

As he turned one of the corners in the corridor, he broke into a run away from Michael and I in the direction of Room 35. As he did so, he began to take out a hockey stick from underneath his coat. This had been completely obscured from my view when I first saw him. At this time, there was a group of other pupils from Year 9, I would estimate there were about 6 pupils in the corridor. RUDAKUBANA raises the stick above his head and swung it down 3 times towards the students that were standing there. A pupil, [DPA] was struck with the hockey stick. I believe he may have been struck twice. I don't recall if RUDAKUBANA was shouting anything.

Michael and I immediately went towards him to try and stop him. Michael reached him just before I did, and was able to restrain him by putting both his arms around RUDAKUBANA from behind, like a bear hug, and keeping his arms by his side, so that he was not able to raise the hockey stick anymore. He held the hockey stick in a two handed grip, and I went around the front of him and just used both of my hands to pull the hockey stick off him. Michael then relaxed the restraint and then ushered him out of the corridor, and I believe he still held on to the back of RUDAKUBANA's arms in order to keep control of him. Michael was taking him to his office at the front of the school.

Michael asked me to check on the boy who had been hit, as I was unsure as to who it was. Michael took RUDAKUBANA into his office with another staff member. I went to see if I could see on our CCTV system if the incident had been recorded, and that's when I was told that the injured party was [DPA] [REDACTED]. It transpired that it was actually RUDKUBANA who told Michael the name of the child he had hit. I then went to the classroom in which [DPA] [REDACTED] was and brought him out of the classroom and took him to the school medical room. I asked that his mother be informed. [DPA] [REDACTED] told me he had been hit on his left arm and showed me. I could see reddening to his arm and red blotches. [DPA] [REDACTED] was very quiet and subdued.

When I went back to Michael's office, the Police had arrived and were talking to RUDAKUBANA and staff members. A short time later, Police took RUDAKUBANA away. Police officers who attended recorded the incident being played on our CCTV system on their Body Cameras. The CCTV will be able to be downloaded in the next few days.

I am willing to assist Police in their investigation and will attend Court if necessary.

7. If identical items are found at the same time and place they may be grouped together under the same exhibit reference number.

Extracting from Codes of Practice

Code C

- 10.1 A person whom there are grounds to suspect of an offence must be cautioned before any questions about it (or further questions if it is his answers to previous questions which provide the grounds for suspicion) are put to him regarding his involvement or suspected involvement in that offence if his answers or his silence (i.e. failure or refusal to answer a question or to answer satisfactorily) may be given in evidence to a court in a prosecution. He therefore need not be cautioned if questions are put for other purposes, for example, solely to establish his identity or his ownership of any vehicle or to obtain information in accordance with any relevant statutory requirement (see paragraph 10.5C) or in furtherance of the proper and effective conduct of a search, (for example to determine the need to search in exercise of the powers of stop and search or to seek co-operation while carrying out a search) or to seek verification of a written record in accordance with paragraph 11.13.
- 10.2 Whenever a person who is not under arrest is initially cautioned or is reminded that he is under caution (see paragraph 10.5) he must at the same time be told that he is not under arrest and is not obliged to remain with the officer (see paragraph 3.15).
- 11.1A An interview is the questioning of a person regarding his involvement or suspected involvement in a criminal offence or offences which, by virtue of paragraph 10.1 of Code C, is required to be carried out under caution. Procedures undertaken under section 7 of the Road Traffic Act 1988 do not constitute interviewing for the purpose of this code.
- 11.1 Following a decision to arrest a suspect he must not be interviewed about the relevant offence except at a police station or other authorised place of detention unless the consequent delay would be likely.
- (a) to lead to interference with or harm to evidence connected with an offence or interference with or physical harm to other people; or
(b) to lead to the alerting of other people suspected of having committed an offence but not yet arrested for it; or
(c) to hinder the recovery of property obtained in consequence of the commission of an offence.
- Interviewing in any of these circumstances shall cease once the relevant risk has been averted or the necessary questions have been put in order to attempt to avert that risk.
- 11D *When a suspect agrees to read records of interviews and of other comments and to sign them as correct, he should be asked to endorse the record with words such as "I agree that this is a correct record of what was said" and add his signature. Where the suspect does not agree with the record, the officer would record the details of any disagreement and then ask the suspect to read these details and sign them to the effect that they accurately reflect his disagreement. Any refusal to sign when asked to do so shall be recorded.*
- 16(5) Where the occupier of premises which are to be entered and searched is present at the time when a constable seeks to execute a warrant to enter and search them, the constable –
- (a) Shall identify himself to the occupier and, if not in uniform, shall produce to him documentary evidence that he is a constable;
(b) Shall produce the warrant to him, and
(c) Shall supply him with a copy of it.

- Section 50 applies to those items seized from premises,
- Section 51 applies to items seized from a person.
- Section 52 requires the provision of serving a written notice to the person from whom the property was seized, specifying various information.

The type of items for which a Section 52 notice should be completed are large amounts of documentation, computers and electronic storage devices.

Reasons for Seizure

The factors to be taken into account in considering, whether or not it is reasonably practicable to complete the relevant process at the scene or time of the stop for something to be determined, or for something to be separated from something else, shall be confined to the following:



- (a) How long it would take to carry out the determination or separation on those premises;
- (b) The number of persons that would be required to carry out that determination or separation on those premises within a reasonable period;
- (c) Whether the determination or separation would (or would if carried out on those premises) involve damage to property;
- (d) The apparatus or equipment that it would be necessary or appropriate to use for the carrying out of the determination or separation, and
- (e) In the case of separation, whether the separation
 - (i) Would be likely, or
 - (ii) If carried out by the only means that are reasonably practicable on those premises, would be likely to prejudice the use of some or all of the separated seizable property for a purpose for which something seized under the power in question is capable of being used.

Notice for person completing the form

If seizure is under **section 50** the name and address of the occupier of the premises from which property has been seized, or where the occupier is not present on the premises at the time of the exercise of the power, the person present on the premises who is in charge of the premises. If there is no such identifiable person, the notice should be left attached in a prominent place on the premises. If the seizure is under **section 51**: the name and address of the person from whom the property has been seized.

His attention was drawn to the accused inside the school premises.</p> <p>MCGARRY has approached AXEL and repeatedly asked the accused to leave, and began asking why he was there. The accused ignored MCGARRY and began to walk into the corridors of the school. Deputy Head Teacher Thomas DOLLY then saw the accused and MCGARRY walking down the corridor. It is alleged that the accused has then started to run, producing a hockey stick from inside his coat as he did so.</p> <p>In the corridor was a group of around 6 Year 9 pupils, one of which was the aggrieved. It is alleged that the accused has swung the hockey stick above his head, and then towards the group, striking the aggrieved on his left arm. MCGARRY has been able to restrain the accused from behind in a 'bear hug'. DOLLY has then taken the hockey stick from the grip of the accused. RUBAKUBANA was escorted to the head teachers office and police were called.</p> <p>Whilst waiting for police to attend, the accused is said to have been very calm and insistent that his actions were not wrong. It is alleged that the accused stated that he had attended the school to look for another pupil to attack.</p> <p>At 0935 hrs , Constable DODD attended the location. MCGARRY explained the circumstances to the officer. RUBAKABANA stated to the officer he had a knife in his backpack. The officer searched the bag and located LD/02 - 1 X KITCHEN KNIFE. MCGARRY passed the officer exhibit LD/01 - 1 X HOCKEY STICK.</p> <p>At 0945 hrs , Constable DODD cautioned and arrested RUBAKABANA on suspicion of Section 47 assault , possession of a bladed article on a school premises and possession of an offensive weapon. He has taken a taxi to the school and has taken with him a hockey stick and a back pack with a kitchen knife in. Axel has attended the school to exact revenge on [DPA] as Axel believes he has been bullied by [DPA] in the past. Axel has not found [DPA] at the school as [DPA] is also currently expelled from the school. Axel not happy with this has ran at [DPA] and hit him three times with a hockey stick. Luckily [DPA] has reacted and covered his face with his arms so the attack has only resulted in reddening to his left arm and a small cut, he has also received painful fingers on his right hand. The headteacher has restrained Axel and taken him to an office to wait for police. On police arrival Axel has revealed he has a kitchen knife in his back pack and has been arrested sus section 47 assault, possession of an offensive weapon and possession of a bladed article and lodged at St ANNE STREET custody. It has later been found out that (a call from Police Officer in Sefton Paul Harrison who states he works with children in schools as part of terrorism PREVENT. He has expressed concerns relating to the DP doing internet searched for beheadings, school shootings and has the intent to kill another student. All this has been relayed to CJMHT and arresting officers to make contact in terms of safeguarding. His intention apparently was to kill the other student today with an adapted hockey stick and if that failed then he would use a knife. Fortunately this child was in today but dp assaulted another student with a hockey stick instead before admitting he had a knife in his bag. All details will be passed to SS and PVPU in terms of supporting the dp.) There are obviously concerns regarding this male, the safeguarding of [DPA] who has no knowledge of the incident but the school will advise his parents of what has transpired today. The mental health team in custody are aware of this male and will assess him in custody.</p>
