SIR ADRIAN FULFORD: Yes, Mr Moss.

MR MOSS: Thank you, sir.

DCI Pye, before I resume my questioning, I think

overnight you were able to check one point in relation

to the packaging of the machete; is that right?

A. That is correct, yes.

Q. Do you want to just clarify that?

A. Yes, so in terms of the machete that was found in

storage, it was in the grey bag. Yesterday, when we were shown the photograph, there was some cardboard on

the table. You asked me whether it had been in that

cardboard when found. I can confirm that it was my

officers, when they went to recover it from storage,

wrapped it in that cardboard and brought it back in the

cardboard and then opened it from the cardboard, so it

would have been found in the grey bag.

Q. Thank you, so the grey packaging as found; the cardboard

we should ignore, that was what the officers carried it in?

A. Yes.

Q. Thank you very much, that is helpful.

an order on 21 June, on 11 July, he chased it saying he still hadn't received it; is that correct?

A. That is correct, yes.

Q. Then, moving the chronology on in relation to the

Hunting and Knives' attempted knife order, the company

replied on 12 July asking for the order number and, on

the same day, 12 July, AR replied giving the order

number; is that correct?

A. That is correct, yes.

Q. From that, it is very obvious, but he had at least got

as far in the ordering process as to generate from

Hunting and Knives a specific order number?

A. That is correct, yes.

Q. Then, jumping on a little bit in your statement, you

very helpfully put everything in chronological order but

we need to jump forward two days to 15 July,

paragraph 66, on the next page.

Is it right that the culmination of this aspect of

his online ordering attempts was that, on 15 July, early

in the morning, Hunting and Knives emailed AR saying,

"Hello", and the name has been redacted because that is

the surname of Samuel:

"... I am sorry to tell you that your order is

pending because you haven't paid yet."

Is that right?

When we paused overnight, we had got to the stage in the chronology where AR had chosen as the company to approach for the purchase of a knife in June 2024, the company Hunting and Knives, from whom it seems he had been able successfully to get his hands on a machete.

Can we look please at your paragraph 58. It is MERP007551 at page 17.

You set out that it was Hunting and Knives, their parent company, or part of a company, called Ageo Wholesale and we will do this with them when they give evidence. This was, I think, a chef's knife, with an approximately 8-inch blade that he attempted to order; is that right?

A. That is right, yes.

Q. In terms of the details that he gave, a first name of Samuel, so that was the driving licence that we dealt with yesterday, I think.

A. That's correct, yes.

Q. A genuine driving licence, but obviously not his, of a man who would have been in his 60s, born in 1961?

A. That is correct, yes.

Q. The billing and shipping address, both the family home at 10 Old School Close, in relation to this and we see, if we go over the page to your paragraph 59, that it seems that, on 11 July, having thought that he placed

A. That is right, yes.

Q. Thank you. We will take all of that up with

Mr Martinez, in terms of how far matters have actually got exactly on that order.

But, just pausing there, in between your paragraphs 61 and 66 that deal with this -- I'm going to come onto it obviously -- you deal with the facts that, in between those two dates, 12 July and 15 July, AR had gone on to make the Amazon order for the knife that was in fact used in the attack?

A. That is correct, yes.

Q. We will also come on to an incident that you have already touched on in your evidence, on 22 July, in relation to AR ordering a taxi for the Range School. What was your assessment, as the SIO, of the significance of the timing of these knife orders in July and the fact that AR was trying to get a knife from two different vendors?

A. We weren't actually certain because the conversation he has with his dad on the 22nd was a conversation that goes along the lines of people from the Range, his age, would be leaving that day. We are not sure whether he was aware of that prior to that conversation and whether he decided on that morning that he is going to go to the Range or whether he had already decided prior to that he

1 was going to the Range. So we was unable to say for
 2 certain whether he was ordering these knives for Hart or
 3 whether it was because he already knew that the Range
 4 was going but then the conversation with dad wouldn't
 5 suggest that he had, on the 22nd.
 6 **Q.** Thank you. So would this be right, that you kept open
 7 two possibilities, one is that these orders of knives in
 8 July were just part of the proclivities, the pattern
 9 that, by now, we have seen in your evidence, of AR
 10 trying to get his hands on bladed weapons?
 11 **A.** That is correct, yes.
 12 **Q.** But the second possibility would be that this was
 13 already with a mind to an attack on the Range School?
 14 **A.** Correct.
 15 **Q.** Thank you.
 16 Can I turn then please to the Amazon order, and we
 17 start with your paragraph 62, so that is back on
 18 page 18, please. It was on the evening, I think, of
 19 13 July that AR first placed an online order for
 20 a single knife, was it, at the first attempt?
 21 Paragraph 62, placed an order for a knife from
 22 Amazon?
 23 **A.** Yes, it was.
 24 **Q.** This was an Apollo Chef Knife, 20 centimetres, about
 25 8 inches and Cerbera was the manufacturer or the name on

1 cancelled?
 2 **A.** He did, yes.
 3 **Q.** He did so, you tell us in paragraph 64, in his own name.
 4 Again, using the "megalania" email address?
 5 **A.** Correct.
 6 **Q.** But this time the IP address was different and was it
 7 one that was associated with a VPN?
 8 **A.** That is correct. It was, yes.
 9 **Q.** So, trying to disguise his location?
 10 **A.** It would appear so, despite the delivery address being
 11 his home address.
 12 **Q.** Thank you.
 13 This is an issue that we will pick up with Amazon
 14 but was your investigation able to determine whether
 15 there was an age verification system used by Amazon at
 16 the point of purchase and, if so, how AR was able to
 17 pass it?
 18 **A.** We weren't, no.
 19 **Q.** Thank you.
 20 Sir, just for your note, we will come to evidence
 21 from Amazon that suggests that there was a form of age
 22 verification but that what AR was able to do was to use
 23 his father's details, which then tallied with the
 24 electoral roll, and that was sufficient, despite the
 25 fact that he was buying it in his name -- entering his

1 it?
 2 **A.** That is right.
 3 **Q.** Let's just look at the details of it. AR gave his
 4 details as his own name; is that right?
 5 **A.** That is right.
 6 **Q.** But the email address, the "megalania" one, is that one
 7 that he had used previously when using the name "Alice"?
 8 **A.** It is, yes.
 9 **Q.** The IP address at that time was the IP address
 10 associated with his home, wasn't it?
 11 **A.** That is correct, yes.
 12 **Q.** Thank you.
 13 Then, in paragraph 63, you deal with the fact that
 14 the history from the Lenovo tablet showed that, very
 15 shortly afterwards, Amazon emailed AR telling him that
 16 the order had been successfully cancelled?
 17 **A.** That is correct.
 18 **Q.** The "successfully" presumably indicating that he had
 19 sought to cancel it?
 20 **A.** Yes.
 21 **Q.** Thank you.
 22 But then less than a minute later, your
 23 paragraph 64, still on 13 July, AR then made an online
 24 order, is this right, for two knives from Amazon of
 25 exactly the same make and brand as the one that he just

1 father's details was sufficient to pass the age
 2 verification at the point of purchase. But all of that,
 3 I think, is something that you didn't go into, perhaps
 4 there was no need to, for the purposes of the criminal
 5 investigation?
 6 **A.** No, we did request the information from Amazon. We were
 7 told by Amazon that they didn't have that information
 8 and also, in terms of delivery, it had been delivered by
 9 a third party called Condor. When we spoke to Condor
 10 they confirmed from the reference number that it would
 11 be a delivery they had made but they didn't hold any
 12 data either, so we were not able to progress it any
 13 further.
 14 **SIR ADRIAN FULFORD:** So Amazon said to you that they didn't
 15 have the information that Mr Moss has just asked you
 16 about?
 17 **A.** Yes.
 18 **SIR ADRIAN FULFORD:** Thank you.
 19 **MR MOSS:** I think I do you a disservice: you asked those
 20 questions but you got a blank?
 21 **A.** Yes.
 22 **MR MOSS:** Again, that's something we can pick up with
 23 Amazon.
 24 **SIR ADRIAN FULFORD:** Please.
 25 **MR MOSS:** Thank you. Then paragraph 69, please -- perhaps

8

1 we should pick it up at 68. Again, the electronic
2 devices show that there was a delivery confirmation
3 email to AR, is that right, "Your package has been
4 delivered!", and that message was delivered at 5.41 in
5 the afternoon on the 15th.

6 **A.** That is correct, yes.

7 **Q.** Thank you. Were you able to establish anything about
8 the age verification process at the point of delivery?

9 **A.** No, we weren't, so as I just explained --

10 **Q.** That is the Condor request that you made?

11 **A.** It was, yes.

12 **Q.** Thank you.

13 You say in paragraph 69 that two Apollo knives,
14 therefore, had been delivered to AR's home at about that
15 time, and we can pick it up in doorbell footage and
16 matters of that kind.

17 But images of the knife associated with this order,
18 you say, were compared with an image of a knife
19 recovered from the Hart Space that appeared to have been
20 used in the attack and they appeared identical; is that
21 correct?

22 **A.** That is correct, yes.

23 **Q.** If we turn to your paragraph 76, which we will remember
24 from yesterday is the very useful paragraph in your
25 statement where you bring together where items were

1 mother on it?

2 **A.** It did, yes.

3 **Q.** Would it be fair to say, though, that you are not able
4 to determine when the finger was applied to that
5 packaging, all you know is that the mother had touched
6 it?

7 **A.** That is correct.

8 **Q.** Sir, for obvious reasons, I don't intend to bring up
9 imagery of the knives but the imagery supporting the
10 questions I have just asked are in our disclosure,
11 MERP002936, but please don't bring it up on screen,
12 obviously. Pages 16 to 17 and page 28 cover the knife
13 and the packaging.

14 **SIR ADRIAN FULFORD:** For 76(f), the Cerbera knife packaging,
15 you presumably weren't able to say which of the two
16 knives that packaging related to or could you say?

17 **A.** No, I wouldn't be able to say, sir.

18 **SIR ADRIAN FULFORD:** Thank you.

19 **MR MOSS:** Thank you. If we just stick with 76 and look at
20 76(h), finally, in the question of knives. You indicate
21 there that a 14-centimetre kitchen knife -- so
22 a different knife -- was found in the bathroom. Do you
23 recall that being part of the things found in the --

24 **A.** Yes, I do recall that, yes.

25 **Q.** Can you help us any more in relation to that? Was that

11

1 found. Can we look at (g), please. You say there that
2 a 20-centimetre knife was:

3 "... found wrapped in a duvet on the sofa in the
4 living room (where police were informed by AR's parents
5 that AR had been sleeping)."

6 **A.** That is correct, yes.

7 **Q.** Would we be right in understanding that that knife
8 appears to have been the second of the two knives that
9 were ordered through Amazon?

10 **A.** That was our assessment, yes.

11 **Q.** The other one being that which was used in the attack?

12 **A.** Yes.

13 **Q.** I think you will be aware -- I don't need to bring it up
14 on screen but, sir, the reference is MERP001217 -- that
15 Dion R, AR's brother, during the investigation said that
16 on Monday, 29 July, at about 11.15, AR left the house:

17 "My mum told me she had found the wrappings of
18 a knife. It said 'Chef's Knife' on the packet."

19 **A.** That is correct, yes.

20 **Q.** Sticking with paragraph 76. I think we see at (f) that
21 knife packaging was found in a carrier bag on the
22 landing?

23 **A.** That is correct, yes.

24 **Q.** Is it right that, as part of the investigation, that
25 packaging was found to have the fingerprints of AR's

10

1 a knife that could, in any sense, be attributed to AR or
2 did it appear to be a knife that perhaps was part of the
3 process of hiding knives from AR elsewhere in the house;
4 were you able to form a view on that?

5 **A.** No, we didn't form any view as to why that was in the
6 bathroom, other than it being an unusual place.

7 **Q.** Thank you.

8 So that brings us to the end, I think, of the
9 questioning that I had in relation to AR's online
10 purchases, both what is known physically about them and
11 from the digital media.

12 I want to come now to issues about the digital
13 devices and you will remember that yesterday you
14 assisted us with what the digital devices showed about
15 AR's online activity on the day and I now want to
16 explore what they show about his previous online
17 activity.

18 Can we pick that up, please, in paragraph 53 of your
19 statement. To a large extent, we have covered much of
20 this ground but it is useful just to remind ourselves of
21 the two tablets. So SMG/3, the older of the two --

22 **A.** Yes, that is correct.

23 **Q.** -- and SMG/2, the newer one, that was purchased on
24 9 October 2023, according to a receipt that was found on
25 it?

12

1 A. That was our assessment, yes.
 2 Q. You indicate there that, once AR had SMG/2, that was the
 3 main device that he used but he still used his older
 4 tablet, to a lesser degree?
 5 A. He did, yes.
 6 Q. In terms of the recovery of those tablets, they were
 7 both found in the home; is that right?
 8 A. They was, yes.
 9 Q. In general terms, was there any indication that other
 10 family members used those tablets or did they just seem
 11 to be AR's?
 12 A. They appeared to be AR's from the forensic testing that
 13 we did and from what the family told us.
 14 Q. Thank you. Turning then to SMG/2, the more recent of
 15 the tablets, paragraph 70 on page 19, please. So, you
 16 provide a long list of pdf documents which were found to
 17 have been on this tablet. Can you help just with this:
 18 were these document titles only that were available or
 19 were some of these capable of having been recovered as
 20 documents themselves?
 21 A. Some of them was -- yes, there is a mixture of both.
 22 Some of them were documents and some of them were
 23 titles.
 24 Q. Thank you. Does that explain why in the disclosure we
 25 have some of these full documents but others all that we

1 with war, conflict, matters of that kind?
 2 A. Yes.
 3 Q. And others were more extreme, obviously relating to
 4 overt violence?
 5 A. Correct.
 6 Q. So that is the pdfs.
 7 In your second statement, please, if we could look
 8 at MERP008308, at paragraph 9. It is on page 2.
 9 At the Inquiry's request, you kindly further
 10 reviewed, in addition to the download pdf list, jpeg and
 11 other imagery that was retained on the device. As you
 12 will see from the screen -- but can we please not bring
 13 it up on screen -- the list of this imagery in the
 14 disclosure is MERP007518 but it is not material that's
 15 fit to be shown in the hearing room. Now, in relation
 16 to this material, at our request, you have given a high
 17 level summary of the type of material; is that right?
 18 A. That is right, yes.
 19 Q. The first that you indicate is slavery of women?
 20 A. Correct.
 21 Q. The second is anti-Islamic material?
 22 A. Yes.
 23 Q. In relation to the anti-Islamic material and insofar as,
 24 after this attack, there may have been suggestions and
 25 speculation about this attack being what might be

1 have is the title?
 2 A. That is right, yes.
 3 Q. Thank you. You indicate, by listing them, the general
 4 nature of them, and I don't intend to read them all, but
 5 would it be right to say that, in general terms, the
 6 titles are suggestive of violence, an interest in
 7 religion and conflict, an interest in Nazi Germany,
 8 Chechnya, the Rwanda genocide, punishment dealt to slave
 9 rebels, the Zulu war, the fight against Isis in Mosul
 10 and things of that kind, as well as a book on ninja.
 11 A. That is correct, a real mixture.
 12 Q. We will come to a similar list with a few particular
 13 documents that I want to draw out from the other tablet
 14 in a moment. But what conclusions did you draw overall,
 15 what assessment overall did you draw about the type of
 16 materials that appear to have been downloaded?
 17 A. AR clearly had an interest in numerous wars, violence.
 18 The family did say that he was interested in studying in
 19 history but the majority of these were quite extreme in
 20 the title or in the material that was found within them.
 21 Q. Thank you. So, within these materials, I think that it
 22 is right to say that some would be of a form of academic
 23 textbook?
 24 A. That is right, yes.
 25 Q. But even those academic textbooks tended to be dealing

14

1 described as an Islamist attack, is it right that the
 2 anti-Islamic material on AR's device, first of all, was
 3 quite voluminous: there was quite a lot of anti-Islamic
 4 material?
 5 A. That is correct, there was, yes.
 6 Q. It is not appropriate for me to ask you about the detail
 7 of them or not to go too far in relation to the detail,
 8 but would it be right that some of that material
 9 involved graphic cartoons of the kind that would be
 10 grossly offensive to anybody of the Muslim faith?
 11 A. That is correct, yes.
 12 Q. Again, in relation to that kind of material, that wasn't
 13 a one off because there were quite a number of images of
 14 that kind?
 15 A. That is correct, yes.
 16 Q. Thirdly, you indicate that there was antisemitic
 17 material?
 18 A. Correct.
 19 Q. And that there was extreme violence including torture?
 20 A. That is correct, yes, there was.
 21 Q. In relation to that, is it right that some of the
 22 imagery appears to have related to historical acts of
 23 torture?
 24 A. Correct.
 25 Q. But, again, without going into inappropriate detail,

1 there was also some imagery of retribution inflicted in
 2 more recent conflicts that seem to have been inflicted
 3 as torture?
 4 **A.** That is correct, yes.
 5 **Q.** Then, bodies of the deceased following atrocities?
 6 **A.** Yes.
 7 **Q.** Included, I think, within that imagery was graphic
 8 photographs of a kind that no mainstream media in the UK
 9 would ever consider publishing?
 10 **A.** That is correct.
 11 **Q.** Nazi-era imagery, including images of those killed by
 12 the Nazis; is that right?
 13 **A.** Yes.
 14 **Q.** And I think one image of the Twin Towers?
 15 **A.** Yes.
 16 **Q.** The volume of that material, would this be right, is
 17 such that it cannot be consistent with a young man who
 18 had come across a wholly inappropriate image during the
 19 course of other searches by accident?
 20 **A.** No, I think that document alone was 247 pages.
 21 **SIR ADRIAN FULFORD:** 247?
 22 **A.** 247.
 23 **SIR ADRIAN FULFORD:** Overall or --
 24 **A.** The overall length of the document, yes.
 25 **MR MOSS:** Thank you.

1 entitled:
 2 "Adolescents' Peer Friendship and Anxiety and

 5 Is that right?
 6 **A.** That is right.
 7 **Q.** Similarly, if we go down towards the bottom of the page,
 8 one of the documents was at (gg):
 9 "A Qualitative Study Exploring Adolescents'
 10 Experiences of Peer Relationships in an Inpatient CAMHS
 11 Setting."
 12 **A.** That's correct, yes.
 13 **Q.** So some exploration of mental health treatment of young
 14 people?
 15 **A.** Correct, yes.
 16 **Q.** I'm going to come onto one particular document within
 17 this list but does it otherwise demonstrate the same
 18 sort of preoccupations and interests as we looked at in
 19 relation to the more recent tablet, so warfare,
 20 weaponry, some academic texts, but other aspects being
 21 more concerning and extreme?
 22 **A.** It does, yes.
 23 **Q.** In this case, Mau Mau insurgency, the Chechen wars, Hutu
 24 insurgency in Rwanda would be examples?
 25 **A.** Yes.

1 If we go back to your first statement then, please,
 2 and if we can turn to paragraph 71. That's at page 20.
 3 So MERP007551, paragraph 71.
 4 I think broadly similarly to the newer device, this
 5 older device -- we are looking now at SMG/3 -- also had
 6 a list of pdfs that AR had downloaded; is that correct?
 7 **A.** Yes, again similar to the other one, some that are pdfs
 8 and some that are just titles.
 9 **Q.** Thank you. One aspect in relation to this, if I just
 10 read the first one, so (a):
 11 "Dionex ... Accelerated Solvent Extractor Operators
 12 Manual."
 13 Then:
 14 "Vibrogel Seismic Extra Gelatin Nitroglycerin
 15 Dynamite."
 16 "Future Warfare Series 59 -- Assessing the Influence
 17 of Hypersonic Weapons on Deterrence."
 18 "d. Electronic Detonators -- Digishot."
 19 Again, some aspects relating to warfare and weaponry
 20 but, of note within this list, is a number of documents
 21 relating to explosives and detonators?
 22 **A.** That is correct, yes.
 23 **Q.** If we go over the page and just look at (k) on the list,
 24 relevant to matters we will be exploring in terms of
 25 AR's mental health treatment, he had access to a pdf

1 **Q.** If we look at 71(z), we see of perhaps particular note
 2 that AR, even on his older device, had access to
 3 a document entitled, "Manslaughter by Reason of
 4 Diminished Responsibility", and that's one that you say
 5 particularly was actually deleted, so we only know the
 6 title?
 7 **A.** That is correct, although we were able to get the data
 8 when that had been accessed.
 9 **Q.** You weren't --
 10 **A.** We were --
 11 **Q.** The date of that --
 12 **A.** July 20 -- the exact date was 17 July 2023.
 13 **Q.** Thank you. Then if we turn over the page, please, to
 14 paragraph 72, also of significance in relation to SMG/3,
 15 the older tablet, was this I think was the device where
 16 your investigation found that AR had downloaded what you
 17 describe here, giving it the title, "Military Studies in
 18 the Jihad Against the Tyrants: The Al-Qaeda Training
 19 Manual".
 20 **A.** That is correct, yes.
 21 **Q.** As you have set out and as was dealt with in the
 22 sentencing of AR, for having possession of this
 23 document, that was a document that he had downloaded
 24 twice: the first time on 30 August 2021; and the second
 25 time on 4 September 2021?

20

1 A. That is correct, yes.
 2 Q. You explain that it is a lengthy document, 190 pages.
 3 Is it right to say that the document itself is a form of
 4 academic article but the danger of it is that it
 5 contains the totality of the text of the manual?
 6 A. It is a research document. There was some redaction
 7 within it. It wasn't the complete -- but the redaction
 8 was quite limited.
 9 Q. But within the material from the manual, in the research
 10 article, as you have set out, was a lesson on tactical
 11 operations. In broad terms, don't go into inappropriate
 12 detail, but in broad terms can you remember what that
 13 dealt with?
 14 A. It encompassed what was in (b) as well, which was the
 15 use of poisons and cold steel.
 16 Q. Yes. So in terms of the illicit nature of that
 17 material, did it give guidance both on the use of
 18 poisons and on the use of knives and stabbing?
 19 A. It did, yes.
 20 Q. That was the material, as I have touched upon, that led
 21 to the conviction for an offence under section 58 of
 22 TACT for AR?
 23 A. It did, yes, it featured quite heavily in our criminal
 24 investigation.
 25 Q. Thank you. I think you can confirm that, even on SMG/3,

21

1 Q. Sir, in relation to that, there are two references which
 2 we don't need to bring up, the first is CTPNW000033, and
 3 MERP007676, which these Core Participants have in their
 4 disclosure.
 5 Turning away from the specific devices, is it right
 6 to say that, when you look across all of the devices
 7 that were seized, first of all, I think some of them
 8 couldn't be accessed and got into?
 9 A. That is correct, yes.
 10 Q. Can you help the Inquiry to understand the extent to
 11 which, as investigators, you felt that you were able to
 12 get the complete picture of AR's online activity or
 13 whether it was more limited? How much of his online
 14 activity do you think you were able to uncover?
 15 A. The majority of it was from SMG/2 and SMG/3. In terms
 16 of the laptop, there was an awful lot of data within the
 17 laptop. We did limit the actual search that we did of
 18 the laptop from 15 July through to 29 July. However, we
 19 did do some keyword searches and we also looked at every
 20 piece of multimedia. But in terms of what we had from
 21 those three devices, there was enough to get a good
 22 understanding of what his internet history had been
 23 like.
 24 Q. Thank you. So far as the early period is concerned,
 25 when AR was younger, we have seen activity and I will

23

1 the older of the tablets, that tablet showed use of
 2 quite a number of different virtual private networks?
 3 A. Yes, it did.
 4 Q. I want to turn back briefly to the laptop next, which
 5 I asked you about in the context of the activity of the
 6 day, if you remember, in deleting his browser history.
 7 That's paragraph 87, please, on page 26 of your
 8 statement. I think your investigation found that
 9 located in the living room; is that right?
 10 A. Yes, it was.
 11 Q. Again, in relation to this laptop, what was the
 12 assessment of your investigation as to the user of this
 13 laptop: was it AR alone or was it shared with the
 14 family, so far as you could tell?
 15 A. No, we believe AR alone had been using it.
 16 Q. We dealt with the deletion of the browser history and
 17 the difficulties that that created, I asked you about
 18 that yesterday, and that, although steps were taken to
 19 recover what could be recovered, that material wasn't
 20 very helpful. I think of the material that was found on
 21 that, you can just confirm that there were stock images
 22 of knives, hammers, black-coloured rucksacks, appearing
 23 to date from around October 2020, I think, found on that
 24 device?
 25 A. That is right, yes.

1 come onto the timing in a moment, but we have seen --
 2 I'm going to look at one particular early example -- but
 3 we have seen concerning activity from the summer of 2021
 4 onwards. To what extent did you have sight of his early
 5 online activity from before that sort of time?
 6 A. There was a couple of USB sticks that we were able to
 7 obtain that contained some older material, but that
 8 would appear to be more educational than what it was,
 9 sort of more graphic as we found in his internet
 10 searches. It was limited as to what we found before the
 11 Al-Qaeda download on SMG/3 in August 2021.
 12 Q. Thank you. Just to pick up on one detail, could we have
 13 on the screen, please, MERP000474. This is a record of
 14 the examination of a hard drive, JLC5, which was seized
 15 on 13 August from AR's bedroom and, as we see here in
 16 the extraction summary, "Hard drive recovered from 10
 17 Old School Close", in the bedroom that was AR's and
 18 shows documents, graphics, videos, audio. If we can
 19 just go over the page, please. I think we can see in
 20 relation to 10 June -- could that just be expanded
 21 a little -- that this was a Word document in which AR
 22 was looking at the chemicals needed for nitrocellulose
 23 and dealing, towards the bottom of the page, with
 24 affixing a blasting cap to a test tube, putting it
 25 together with duct tape and matters of that kind, acid

24

1 used to make it and the chemicals needed.

2 So that appears to be a deliberately made Word

3 document by AR in relation to explosives, as early as

4 June 2021; would you agree?

5 **A.** Yes, we assessed them as three self-generated documents.

6 **Q.** Self-generated documents?

7 **A.** Yes, created by someone.

8 **Q.** Created by somebody?

9 **A.** Yes.

10 **Q.** So not necessarily written but, as a Word document,

11 nevertheless on his hard drive?

12 **A.** Yes.

13 **Q.** Was that, in fact, in terms of documents that you could

14 date and say specifically "That is an AR-related

15 document which we can ascribe to a date", is that the

16 earliest specific document that you could date of

17 material of concern?

18 **A.** I wouldn't be able to comment on the actual date of it.

19 **Q.** But, in any event, this, I think, being June 2021, is

20 slightly before the Al-Qaeda material?

21 **A.** Yes.

22 **Q.** Thank you. Just in terms of putting this in context of

23 some evidence that we will hear later in the Inquiry,

24 I think you will be aware in general terms that the last

25 of the Prevent referrals was closed on 10 May 2021?

25

1 indicated that the Range School broke up, just gone

2 midday, so a half school day, on 22 July; is that right?

3 **A.** That is right, yes.

4 **Q.** I think your investigation included dealing with the

5 teaching staff there who made you aware that the

6 breaking up day was publicly available from the school?

7 **A.** He did, yes.

8 **Q.** Then paragraph 102 from your investigation and your

9 dealings with One Call Taxis, you were able to find

10 that, first of all, there was a call to the automated

11 booking system on 22 July from AR's mobile phone, is

12 that right, on that day?

13 **A.** That is correct, yes.

14 **Q.** Over the page. There was first, I think, a failed call

15 at 12.20?

16 **A.** Yes.

17 **Q.** Then paragraph 104, a further call from the number

18 associated with the Nokia phone. The automated system

19 that we have heard about from you in relation to the

20 attack on the 29th, and the caller, AR, when asked his

21 name says "Er ... Simon".

22 **A.** That is correct, yes.

23 **Q.** That brings us back, doesn't it, to when he used the

24 same system on the 29th, recognising him and thinking

25 that it was someone called Simon?

27

1 **A.** Yes.

2 **Q.** So the specific materials that I have been taking you

3 to, with dates attached and the purchases, I think did

4 start thereafter, insofar as the investigation was able

5 to find them?

6 **A.** That is correct, yes.

7 **Q.** Was your investigation aware in general terms, however,

8 that there were concerns, even before that time, as to

9 what AR had been looking at online, at least in his

10 schools?

11 **A.** Yes. I was aware very, very early on within the

12 investigation.

13 **Q.** That, in itself, as we will hear, formed part of the

14 Prevent referrals?

15 **A.** Yes.

16 **Q.** Thank you.

17 I want to come next, please, moving away from the

18 digital material, to the events of 22 July. You start

19 this in paragraph 100 of your statement, please. So

20 back in MERP007551 at page 29.

21 You helpfully remind us of the context for this. So

22 2019, AR was excluded from the Range High School and he

23 then, in December 2019 went back to that school, having

24 been excluded from it, and assaulted a pupil.

25 Then moving forward to July 2024. You have

26

1 **A.** Correct. We covered that yesterday.

2 **Q.** When then asked for the pick-up location, AR gave his

3 home address but his destination he stated was Range

4 High School in Formby?

5 **A.** Yes.

6 **Q.** You obtained evidence from Mr Evanson of One Call Taxis?

7 **A.** Yes.

8 **Q.** He co-operated with your inquiry?

9 **A.** He did, yes. Our attention was brought to that from the

10 Nokia phone, which we recovered from the scene, so we

11 had that information by the Tuesday when we spoke to the

12 taxi driver.

13 **Q.** Thank you. You set out the essence of what Evanson told

14 you about the 22nd in your paragraph 106, so just

15 dealing with that. He recalls arriving there at about

16 12.30 but you were able to establish from the Ring

17 doorbell footage that it was a bit later, at 12.45?

18 **A.** Yes.

19 **Q.** "A boy came out of the house ..."

20 We can safely assume it is AR, so AR came out of the

21 house, "hood up ... Covid-style mask on", similar to the

22 29th?

23 **A.** Yes.

24 **Q.** Got into the rear of the taxi and, in addition to having

25 stated on the automated system "Range High School", no

28

1 doubt about it because he repeated it to Mr Evanson, the
 2 taxi driver?
 3 **A.** Correct.
 4 **Q.** As the driver is about to set-off, I think he told your
 5 investigation that a man came running out of the house
 6 and I don't think there's going to be any dispute that
 7 that was Alphonse R, AR's father?
 8 **A.** That is correct and that was captured on the Ring
 9 doorbell.
 10 **Q.** Thank you. As the taxi driver explained it to your
 11 investigation, is this right, AR's father was pleading
 12 with the taxi driver "Don't take him, don't take him",
 13 and AR was saying in response, "I'm 18, I wanna go, take
 14 me".
 15 **A.** Yes.
 16 **Q.** An argument was going on. Was that an argument between
 17 AR and his father?
 18 **A.** It was, yes, but it appeared to be almost through the
 19 taxi driver.
 20 **Q.** Thank you. The taxi driver didn't want to get in the
 21 middle of a domestic and so told AR that he would not be
 22 able to take him, and you summarise that the taxi driver
 23 described AR as calm and stated that he got out of the
 24 taxi without an issue when he, the taxi driver, had
 25 asked him to do so?

29

1 asked me about the knives on the 15th, that would
 2 suggest that AR wasn't aware that morning that it was
 3 finishing until he asked his father.
 4 **Q.** Thank you. So that may suggest that the knives had been
 5 bought as part of a general proclivity, rather than as
 6 a part of a targeted attack on the Range?
 7 **A.** Correct.
 8 **Q.** Unless this was a form of false naivety on AR's part and
 9 he was just getting confirmation?
 10 **A.** Correct, that is right, as well, yeah.
 11 **Q.** Then paragraph 109, still recounting Alphonse R's
 12 account. At some stage after midday, his father said
 13 that he realised that AR had called a taxi -- you say
 14 that he didn't state how he realised that and that's
 15 something we will pick up with him -- if he knew that AR
 16 was planning to go to the Range High School, you comment
 17 that his father didn't state how he realised that, and
 18 that Alphonse R stated that he called the taxi company
 19 but they would not confirm whether a taxi had been
 20 booked to his address or not?
 21 **A.** That is right.
 22 **Q.** That's something we will pick up in evidence with One
 23 Call Taxis later this week. Then the taxi, as
 24 Mr Evanson as we now know it was, arrived and AR's
 25 father recounts he got in the back with his rucksack,

31

1 **A.** Yes.
 2 **Q.** The visual imagery of all of this, I think you can
 3 confirm, is captured on Ring doorbell footage?
 4 **A.** It is, yes.
 5 **Q.** The taxi driver then raised that he had had to travel
 6 out from Southport to do the pick up and AR's father
 7 gave the taxi driver £5 to seek to cover that; is that
 8 right?
 9 **A.** Correct.
 10 **Q.** Then at 107, you detail that Alphonse R, AR's father,
 11 explained about this day during the course of your
 12 investigation at 108, so dealing now with Alphonse R's
 13 account of this. AR had been at home with Alphonse, and
 14 Alphonse -- he explains that AR was wearing the green
 15 hoodie, so I think exactly the same clothing, I think,
 16 as the 29th, in terms of the hoodie?
 17 **A.** Yes.
 18 **Q.** He -- AR that is -- asked his father when the Range
 19 School broke up for the summer, and Alphonse looked on
 20 his phone and saw that it was the last day of term that
 21 day. Alphonse made a comment to the effect of, "They'll
 22 all be going off to university now", to which AR replied
 23 with words to the effect of, "Well, I won't be, will I?"
 24 Is that right?
 25 **A.** That is correct. And it's that line as to why, when you

30

1 and Alphonse R, I think, told your investigation what's
 2 visible in the footage, that he went out and, consistent
 3 with what the taxi driver said, pleaded with the taxi
 4 driver not to take AR, with the taxi driver eventually
 5 agreeing and AR being told to get out of the taxi?
 6 **A.** That is correct, yes.
 7 **Q.** In terms of what happened thereafter -- so they are both
 8 out on the street at that stage, the taxi driver is
 9 being paid off -- what then happened?
 10 **A.** AR got out of the taxi, he went back into the house,
 11 shut the door and Alphonse stayed outside.
 12 **Q.** Did Alphonse stay outside for some considerable time?
 13 **A.** Did he what?
 14 **Q.** Stay outside for some considerable time?
 15 **A.** He did, he contacted AR's mother, who came home from
 16 work and I believe they stayed outside until a time that
 17 the mother would have returned and they went back into
 18 the house as if nothing had happened.
 19 **Q.** Thank you.
 20 Sir, the videos in relation to this are available --
 21 but please don't bring them up on screen -- but they are
 22 available for you, sir, at MERP006461 through to
 23 MERP006468.
 24 **SIR ADRIAN FULFORD:** Thank you.
 25 **MR MOSS:** But because they show AR in the hoodie, and so on,

32

1 we are not going to play them.

2 If we go to your paragraph 114 -- 113 perhaps we
3 should pick it up at first, bottom of the page, 31 --
4 what did your investigation conclude then as to the
5 events of the 22nd and the apparent intention of AR?

6 **A.** We believe, when you take all the information into
7 consideration, the fact that he had previously been at
8 that school, there had been a bully at that school he
9 had had issues with, he had previously been to the
10 school with a knife in a bag and attacked a pupil there,
11 the conversation he had that day with his father, the
12 fact that he had a rucksack, we believe he was
13 potentially going back to that school to attack
14 somebody.

15 **Q.** In relation to AR's father, is it right that AR's father
16 suspected that AR had a weapon on him that day?

17 **A.** That's what he explained to us, yes.

18 **Q.** I think your investigation didn't find any evidence that
19 Alphonse R had called the police --

20 **A.** He didn't, no.

21 **Q.** -- or later informed the police about this, other than
22 during the investigation?

23 **A.** Yes, that is correct.

24 **Q.** Nor did Alphonse R claim to you, when he spoke to you in
25 the investigation or to your team in the investigation,

33

1 an occasion when a parcel was delivered to the family
2 home, he was asked to sign for it because it contained
3 knives, and he told your investigators that he signed
4 for it but did not give the parcel to AR. That broadly
5 tallies with the find on the top of the wardrobe in the
6 parent's bedroom; would you agree?

7 **A.** That is correct, with a knife and sharpening stone.

8 **Q.** With the possible exception that the item might more
9 normally be described as a machete, rather than a knife?

10 **A.** That's right, yes.

11 **Q.** In addition to that, I think, Alphonse R did explain to
12 your investigators that on the same day, 22 July, as the
13 taxi booked to the Range School, that it was on that day
14 that, what I think he would suggest was a rare
15 occurrence, when he was able to get into AR's room, and
16 Alphonse R saw a number of items on that occasion,
17 including the containers, for example, that were later
18 found to contain ricin. Do you recall that?

19 **A.** Yes. He admitted that he had touched the alcohol that
20 was in his room at that point, on which his fingerprint
21 was also found on the alcohol bottle.

22 **Q.** They knew about the events on 22 July because Alphonse R
23 had been outside with the taxi driver and I think you
24 were able to establish that there was then communication
25 between him and his wife about that on the 22nd?

35

1 he didn't make any claim that he had reported this?

2 **A.** No.

3 **Q.** Thank you.

4 In that context then, if we turn to paragraph 115 of
5 your statement, you indicate, in terms of the knowledge
6 of AR's family, that that was something that your
7 investigation considered, whether and to what extent
8 AR's immediate family were aware of items of concern and
9 whether they shared AR's mindset and proclivities
10 towards violence and the use of weapons.

11 You explain in paragraph 116, would this be right,
12 that, in general terms, AR's parents did have some
13 knowledge of his possession of bladed items?

14 **A.** Yes.

15 **Q.** They told you that and Alphonse R had described to your
16 investigators incidents where AR took a knife into
17 school for about a week. I think that tallies with the
18 Childline incident?

19 **A.** That is correct, yes.

20 **Q.** And another incident where he went to school with
21 a knife taken from the family's kitchen, which, as you
22 say in your paragraph 116, tallies with the December
23 2019 Range School attack?

24 **A.** Yes.

25 **Q.** He also described to investigators in your team

34

1 **A.** Yes.

2 **Q.** In addition to that, as you dealt with in your
3 paragraph 117, as we will come to in later evidence, the
4 Child and Adolescent Mental Health Services, CAMHS, had
5 advised AR's parents to remove knives from the address
6 or secure them?

7 **A.** That is right, there were numerous references within the
8 third-party material.

9 **Q.** So all of that, and there's more as well, gives rise to
10 issues that this Inquiry will explore about the extent
11 of AR's parents' knowledge and the adequacy of steps
12 that they took in response. But did you, in the
13 investigation, find any evidence at all that AR's
14 parents, in any form, sympathised with violent attacks
15 or had that mindset?

16 **A.** We didn't, no. It is fair to say they must have known
17 of the weapons but we didn't find anything to suggest at
18 all that they sympathised with him.

19 **Q.** In terms of online activity, AR's fascination and
20 interest in torture, extreme violence, Nazi Germany,
21 matters of that kind, did you find any evidence across
22 the family devices, because obviously lots of items were
23 seized, did you find any evidence at all that AR's
24 parents shared an interest in extreme violence, matters
25 of that kind?

36

1 A. We didn't. We obtained hundreds of thousands of
2 messages, more or less from the mother's phone, but
3 there was nothing to suggest that they shared that level
4 of violence at all.

5 Q. Thank you.

6 Now, the upshot, of course, of the investigation was
7 the convictions of AR, of which the Chair is, by now,
8 extremely familiar and I don't need to go on to deal
9 with in detail.

10 But I want to just ask you a few more questions
11 about AR's ideology and his motivation.

12 When seen as a whole, did you find evidence that
13 AR's actions were motivated by any ideological cause,
14 whether political or religious or racial?

15 A. We didn't and that was under constant review, as well,
16 from the head of the counter-terrorism police, who
17 actually made that decision. It was not us who would
18 make that decision, it would be them and we didn't find
19 anything. As you pointed out, there was quite a lot of
20 anti-Islamic material as well.

21 Q. Thank you. So although we know of AR's conviction of
22 a terrorism offence because he possessed the research
23 paper with the Al-Qaeda material in it, would it be fair
24 to say that, seen as a whole, that there was no evidence
25 that AR subscribed to an extreme form of Islam or indeed

37

1 a fascination with violence and inappropriate material
2 but not somebody who was motivated by any particular
3 religion, racial hatred or matters of that kind?

4 A. That is correct, and I must say I'm grateful to Counter
5 Terrorism Policing for the support that they gave us all
6 the way through. It did allow us to expedite some of
7 the inquiries that we did.

8 MR MOSS: Thank you.

9 DCI Pye, thank you very much for the evidence you
10 have given, you have given a very lengthy and helpful
11 statement and evidence over a long period of time.

12 I should just give you the opportunity if there are any
13 matters that I haven't covered that you think it may be
14 important for this Inquiry to hear?

15 A. If I could, and you wouldn't mind just maybe the extent
16 of the investigation.

17 Obviously it was quite over a lengthy period, would
18 that be okay?

19 Q. Yes, of course?

20 A. So it totalled -- I had responsibility for over 80
21 officers. We -- 37 of those was used to support the
22 families, and that was all 29 victims that we had
23 identified, and if I can I would just like to say I'm
24 grateful for the support that we received from some of
25 our neighbouring forces, mutual aid and family liaison

1 Islam at all?

2 A. There wasn't and that was something that we kept very
3 open minded about all the way through the investigation.

4 Q. As I have asked you about and you touched on a moment
5 ago, yes, an image of the Twin Towers but, looked at in
6 the round, more anti-Islamic material than anything
7 specifically agreeing with an Islamist agenda?

8 A. That is correct, yes.

9 Q. There is quite a lot of detail that sits behind this,
10 I think, which we don't need to go into but if your
11 investigation as it proceeded had found significant
12 evidence of a religious, racial or political ideology,
13 suggesting a terrorist motivation, would it be right
14 that primacy for the investigation would likely have
15 passed to the counter-terrorism police?

16 A. Yes, normally but, after the first couple of weeks,
17 there was a conversation as to whether it would probably
18 go to a counter-terrorism SIO but probably would have
19 remained with the investigation team because of the size
20 of the investigation.

21 Q. I think Counter Terrorism Policing -- and we will hear
22 evidence about this -- assisted and were involved and
23 helped analyse the material. Should we understand that,
24 throughout the investigation, that the pattern that
25 developed was: this was a young man who had

1 officers as well, which spoke to 547 witnesses; made 78
2 safeguarding referrals; 405 statements were taken, of
3 which 17 of them were Achieving Best Evidence videos; 80

17 I would like to say thank you to the mutual aid that we
18 received to assist Merseyside Police. That's it, thank
19 you.

20 MR MOSS: Thank you.

21 I'm just going to check in the position I had
22 overnight. I don't think there are likely to be any
23 questions. There were two Core Participants who asked
24 for permission but it may be that I have covered the
25 ground. There doesn't seem to be any questions.

1 **SIR ADRIAN FULFORD:** Thank you.
 2 Detective Chief Inspector, it tends to be forgotten
 3 that these events can take a toll even on experienced
 4 investigating officers. You have needed to liaise with
 5 a significant number of extremely distressed individuals

 7 disturbing event.
 8 This included the need to gain a real understanding
 9 of the precise sequence of events by viewing over and
 10 over again some truly upsetting CCTV clips. You had to
 11 delve, as you have told us this morning, insofar as one

 13 that he was researching on the internet.
 14 There is not the slightest suggestion that you did
 15 all of that to anything less than the highest
 16 professional standards, and you have my thanks on behalf
 17 of the public for your highly effective contribution and
 18 those of your brother and sister officers to the
 19 criminal investigation and to this Inquiry.
 20 So you leave the witness box with my thanks.
 21 **A.** Thank you.
 22 **SIR ADRIAN FULFORD:** You can withdraw now. Thank you very
 23 much.
 24 **MR MOSS:** Sir, I wonder if we might take a break?
 25 **SIR ADRIAN FULFORD:** Certainly.

 20 officers;
 21 (h) Further witness statements provided to the
 22 Inquiry regarding Alice's treatment, comprising: 9 North
 23 West Ambulance Service statements; 9 statements of Alder
 24 Hey Hospital clinicians; 1 statement from a Southport
 25 and Formby District General Hospital clinician; and

1 **MR MOSS:** We will deal, after the break, if we may, with the
 2 summary of Professor Lyon's evidence but that will take
 3 some time for me to present.
 4 **SIR ADRIAN FULFORD:** Certainly. I will sit again at

 12 This is a summary of the most relevant content of
 13 the expert medical report of Professor Richard Lyon,
 14 Consultant in Emergency Medicine and Pre-hospital Care,
 15 regarding the death of Alice da Silva Aguiar and the
 16 survivability of her injuries. The full report
 17 (PFL000001) has been circulated to the Core
 18 Participants. It rightly contains comprehensive
 19 clinical information regarding Alice's injuries, the
 20 full details of which are distressing for her family.
 21 In light of the fact that Professor Lyon's conclusions
 22 are not being challenged in this Inquiry by any Core
 23 Participant, this summary seeks to put into the public
 24 domain the material parts of Professor Lyon's report
 25 without the full clinical details that would be most
 42

1 1 further statement from a Merseyside Police Officer;
 2 (i) A dramatis, timeline, schedule of Rule 9
 3 requests and a summary of Helicopter Emergency Medical
 4 Services (HEMS) information provided by the Inquiry.
 5 Professor Lyon sets out a summary of his CV, which
 6 in the published version will be annexed to the summary
 7 that I'm reading.
 8 Professor Lyon sets out a detailed timeline
 9 regarding Alice's treatment from the evidence he has
 10 reviewed. Without repeating that entire chronology, the
 11 core timings and sequence are as follows:
 12 (a) The CCTV shows Alice running out of the Hart
 13 Space at 11.46.28.
 14 (b) She ran to the white BMW in the carpark and
 15 ended up lying on the far side of the BMW.
 16 (c) Alice was picked up from near the BMW by Joel
 17 Verite and carried towards 34 Hart Street. Professor
 18 Lyon considers that Alice appeared unconscious when
 19 carried by him. Outside 34 Hart Street, Alice was
 20 assisted there by Marcin Tyjon and by Andrew Batchelor
 21 who was relaying information on a 999 call.
 22 (d) The first North West Ambulance Service (NWS) crew
 23 were next to Alice at 11.59.02.
 24 (e) Still at the scene,
 25 (i) Firstly, Cardio Pulmonary Resuscitation was
 44

1 started by NWS clinicians and Alice's airway was
2 secured with an i-gel airway. A Merseyside Police
3 officer assisted by performing CPR under NWS direction.

4 (ii) Secondly, Alice had chest seals applied,
5 intraosseous access was obtained with appropriate
6 medications administered, bilateral needle chest
7 decompressions were performed, and these were upgraded
8 by an advanced paramedic to bilateral thoracostomies.

9 (f) The decision made to take Alice by road
10 ambulance to Southport and Formby District General
11 Hospital because this was the nearest Emergency
12 Department.

13 (g) The ambulance left with Alice at 12.33. She had
14 a single defibrillator shock administered whilst en
15 route to hospital when her cardiac rhythm had briefly
16 changed from pulseless electrical activity (PEA) to
17 ventricular fibrillation (VF).

18 (h) Alice arrived at Southport and Formby District
19 General Hospital at 12.41 and was in the resuscitation
20 room by 12.43.20.

21 (i) The decision was made to send a paediatric
22 surgical team from Alder Hey to Southport and Formby
23 District General Hospital who took part in further
24 surgical intervention.

25 (j) Alice was later transferred from Southport

1 (e) The lack of heart movement on the ultrasound
2 scan taken at Southport Hospital implied a virtually
3 zero chance of survival.

4 (f) The only theoretical possibility where Alice
5 could have survived from her inflicted injuries would
6 have been for her to receive a blood transfusion before
7 she went into cardiac arrest. A blood transfusion would
8 have needed to have been initiated, with a sufficient
9 volume of blood products immediately available on scene
10 to maintain her circulating blood volume, until Alice
11 could undergo emergency thoracic surgery. But given the
12 context of this incident, and the timing and location of
13 Alice's cardiac arrest, and the available emergency
14 medical resources, it would not have been possible for
15 Alice to survive her injuries.

16 (g) The immediate lay bystander response that Alice
17 received was commendable but there was nothing that the
18 bystanders could have done to prevent Alice from going
19 into cardiac arrest at the scene.

20 (h) Alice received rapid care, with both Merseyside
21 Police and NWS being on scene within a small number of
22 minutes. Given the complexity of this incident,
23 consideration being needed for responder and scene
24 safety and the multiple patients involved, this response
25 timeframe was commendable. The delay in attending other

1 hospital to Alder Hey Hospital arriving at 21.20 in the
2 Emergency Department, and after further testing she was
3 admitted to Paediatric Intensive Care.

4 (k) Alice suffered further cardiac arrest and was
5 pronounced life extinct at 01.20 on 30 July 2024.

6 In his opinion section, Professor Lyon has provided
7 the following expert opinion:

8 (a) Alice sustained critical internal injuries as
9 a result of being stabbed. Alice was bleeding
10 internally into her chest from several different sites.
11 The type of bleeding this caused was slower than
12 arterial bleeding, which is why -- for a short period of
13 time -- Alice was able to run from the scene, before
14 collapsing from critical blood loss. Alice would have
15 quickly collapsed and lost consciousness, and then gone
16 into cardiac arrest. The cardiac arrest most likely
17 occurred when Alice was still at the BMW.

18 (b) It would not have been possible to prevent Alice
19 suffering a cardiac arrest at the scene.

20 (c) Once Alice had suffered the cardiac arrest, her
21 probability of meaningful survival would have been less
22 than 2 per cent.

23 (d) Alice would have suffered irreversible brain
24 injury from lack of oxygen to the brain due to the
25 period for which she was in cardiac arrest.

1 patients was minimal, a paramedic attending to Alice
2 would not have been able to prevent her deteriorating
3 into traumatic cardiac arrest if she was not already in
4 cardiac arrest.

5 (i) While the overall ambulance dispatch and
6 management processes of NWS would be a matter for
7 an expert in ambulance operational command and
8 management, Professor Lyon considers the NWS system to
9 have been entirely appropriate.

10 (j) Given the nature of this incident, NWS
11 paramedics should be commended for performing a dynamic
12 risk assessment and attending the scene without any
13 significant delay or holding at a rendezvous point.
14 Professor Lyon considers that Alice received rapid
15 medical care from NWS and that there was minimal, if
16 any, delay in Alice receiving emergency medical care in
17 the context of this type of incident.

18 (k) The bystanders correctly attempted to control
19 Alice's external bleeding. The paramedics who attended
20 to Alice correctly followed the standard European
21 Resuscitation Council guidance and provided rapid,
22 high-quality care.

23 (l) As regards triaging decisions, the first
24 paramedic on scene performed the correct actions of
25 undertaking a dynamic risk assessment, proceeding to the

location where patients were present and followed the standard approach to a scene where multiple casualties are present by assessing the entire scene to assess the overall scale of the incident, prior to triaging and treating individual patients. While Mr Tyjon observed that other patients received care prior to Alice, in the context of a major incident, particularly with the complexity that would have been present with multiple stabbed children, where the triage process had not yet been completed for all patients, this short delay was negligible and had no impact on Alice's outcome.

A particular challenge of complex and major incidents where multiple patients are triaged as "P1 -- priority 1", is which P1 patients to attend to first until the incident is fully resourced with ambulance responders. The first paramedic to attend to Alice was having to assess her and another patient who was lying next to Alice, who was also critically injured.

(m) The timeline and sequence of paramedic treatment given to Alice at the scene was entirely appropriate. The pre-hospital care that Alice received was of high quality and was entirely adequate and appropriate.

(n) If a HEMS team had been present prior to Alice departing for hospital, there would have been consideration given to performing a pre-hospital

incident.

(q) As to Alice's care at Southport and Formby District General Hospital, there was no delay in recognising Alice's condition, appropriate tests and assessments were carried out and all necessary equipment, medications and products were available to treat Alice.

(r) The decision later to transfer Alice to Alder Hey was entirely reasonable. Earlier transfer to Alder Hey would not have changed the outcome. Alice was too unstable for transfer prior to undergoing damage control surgery at Southport.

(s) Professor Lyon could find no significant issues or delays in Alice's care at Alder Hey Hospital. Professor Lyon agrees with the statement of one of the Alder Hey clinicians that Alice deteriorated despite maximum treatment in the intensive care setting and by then her condition was such that there was no hope of recovery.

Professor Lyon has commented that it should be remembered that an incident involving multiple children with severe penetrating injuries is a very rare occurrence, likely to be a once-in-a-career event for many of the clinicians involved. The emotional burden of such an event is also extreme. In his opinion, given

51

resuscitative thoracotomy. They may have not have conducted that procedure because of the other casualties and the duration of Alice's cardiac arrest and, in Professor Lyon's view, even if conducted at the scene, the procedure would not have changed the outcome because of the nature of Alice's injuries and the duration of her cardiac arrest. Similarly, even if Alice had been provided with blood/blood products by the first HEMS resources on the scene, this would not have changed her outcome.

(o) Alice received high-quality care during ambulance transfer to Southport Hospital and during her time in the Emergency Department at Southport and Formby District General Hospital. It was entirely appropriate to take Alice to the nearest trauma unit hospital, which was Southport and Formby District General Hospital, by road ambulance, rather than to Alder Hey Hospital in Liverpool. It would not have been appropriate to transfer Alice by air, in an air ambulance helicopter, whilst she was in cardiac arrest. It is not possible to perform high-quality CPR in the back of a helicopter.

(p) Alice was the first patient to leave the scene. The time from incident start to Alice leaving scene was 46 minutes. This timeframe is acceptable and to be expected in the context of a complex multi-patient

this context, Alice received exemplary care that may not have been possible in other parts of the United Kingdom. Alice had less than 2 per cent chance of survival of her injuries at the scene, with her subsequent assessment in A&E suggesting a 100 per cent mortality rate. Commenting on the view of one treating clinician, who had not considered the pre-hospital or Emergency Department events in detail, as Professor Lyon has done, Professor Lyon's opinion is that earlier damage control surgery would not have changed the outcome and Alice's injuries were non-survivable from the outset.

Sir, Professor Lyon was asked to comment on future lessons. Whilst there are no specific lessons identified by him from Alice's treatment, he has highlighted a few more general areas in terms of preventing future fatalities in similar incidents:

First, gaining situational awareness of a complex scene when multiple 999 calls are received from the public.

Next, use of chest seals and blood control kits by lay responders. The use of lay person bleed control kits could be more widely adopted. The use of chest seals in these kits could also be considered in future. There will always be a challenge in the location of these kits and making enough immediately accessible.

1 Whilst efforts are underway to place such kits in high
 2 risk locations for penetrating injuries (for example in
 3 pubs and nightclubs), it would be highly unusual to have
 4 such a kit located in a building such as the Hart Space.
 5 Next, lack of urgency, delay or reluctance to
 6 declare a major incident.
 7 Next, early tasking of HEMS and consultant-level
 8 pre-hospital emergency medicine responders to scene to
 9 aid in clinical decision-making and also bring enhanced
 10 care, including critical interventions, such as
 11 thoracotomy, to scene as early as possible.
 12 Next, ensuring intra-operability and communication
 13 between police and ambulance service and early use of
 14 the M/ETHANE reporting system.
 15 Ensuring rapid and effective role allocation at
 16 scene.
 17 Finally, making blood products available early at
 18 scene. This would be especially important for incidents
 19 occurring in remote or rural locations, necessitating
 20 prolonged ambulance transport times to hospital.
 21 Professor Lyon concludes his report by paying
 22 tribute to the efforts made by bystanders, NWS crews,
 23 and the Southport and Alder Hey hospital teams, in what
 24 he describes as their outstanding response to this
 25 terrible incident, and for the commendable attempt to
