On 8th October 2019 The Range School, FORMBY where Axel attended school were contacted. As a result, Axels school bag was searched and no knife was found. He was subsequently spoken to and his mother informed.

Axel was given detention he previous week at The Range school where he commented 'THIS IS WHY TEACHERS GET MURDERED'. He was asked about this remark and he stated that it was an off the cuff remark. Due to Axel carrying a knife at School and saying that he could use it was additionally concerning.

As a result, Axel was indefinitely excluded from school whilst a decision is made about his future at The Range School.

On 17th October 2019 Axel was admitted to Acorns School in Lancashire after he was permanently excluded from the Range High School in Sefton after taking a knife into school to injure a fellow pupil. Since being at Acorns School Axel has caused concerns to staff at the school.

On 15th November 2019 during an ICT lesson Axel was found to be searching school shootings in America.

This was reported to his father who stated that Axel stated that he had only opened a link to a news article.

The school have not provided the URL or details of the internet history of Axel – (they have been spoken to on 10/12/2019 and are making enquiries with their internet provider if they can obtain this information).

In the short time he has been at The Acorns School Axel has made comments about murder, severed heads, guns and YouTube videos of people hurting themselves.

A CAF (referral to social services) has been made by the school in relation to Axel.

	<p>no action taken in relation to him carrying a knife in public a high risk vulnerable child referral was submitted to Lancashire Social Services.</p> <p>On Wednesday 11th December 2019 call was received from Merseyside FIMU that Axel had been arrested in Merseyside as he had pre booked a taxi the previous day and travelled to The Range School with a hockey stick and a large knife in his bag to stab [DPA] who has been bullying him.</p> <p>Axel remained in custody until 2300 hours on 11th December 2019 and was bailed to return to Merseyside custody at 1400 hours on 12/12/2019 to be interviewed in relation to the matter.</p> <p>Pending update from Merseyside....</p> <p>I have reviewed the above information in relation to Axel, this is a young lad who has a number of issues. Both his parents are fully aware of this referral. There is very little known about the family on Lancashire Police systems.</p> <p>This is a concerning individual who has initially been bullied and has then progressed to viewing school shootings and severed heads and people hurting themselves.</p> <p>It is unknown what access he has to the internet at home and if he has viewed anything of CT DE concern at his home address.</p>
