Investigation Summary

CLOSED - HIGH RISK VA PVP - A referral came from ChildLine regarding Axel, who had made concerning comments to them. Axel has been bullied by a male called [DPA] and Axel has become highly agitated and frustrated regarding this. As a result Axel has taken a knife from his kitchen to school on several occasions.

Axel was spoken to by police and admitted to taking the knife to school previously. He seemed honest throughout and told us that if things escalated with [DPA] then he believes he may use the knife.

Axel was informed of the severity of the offence of simply carrying a knife. He seemed to understand this and became somewhat upset but did seem genuinely frustrated about the bullying. Though the school have taken some safeguarding steps it appears they haven't fully tackled the issues.

The school he attends is RANGE SCHOOL, FORMBY, who have been emailed to appraise them of this. The log has also been deferred for the attention of the AM Sergeant to call the school regarding it so that they can take further action.

Axel's mother is supportive of police investigation and had noticed her knife was missing, though she got it back from Axel as soon as she realised and has now hidden them all.

There was some suggestion from Axels mother that he may suffer from Autism however this is not diagnosed nor confirmed. His brother, Dion, [DPA] is in a wheelchair. There is additional risk in case Axels behaviour deteriorates to the point where negative behaviour is also developed at home.

Axel and his mother Laetita both consented to their details being shared.

CSC Checks - Axel is not known to CSC however his brother is known to CSC.

Referred to CSC as Axel has been the victim of bullying at b school has resorted to taking a knife into school as the matter has not been resolved. Axel action's place both himself and other at risk of harm.

Information In/Received Officer - PC 04 4658 McNamee	08/10/2019 15:50	Spoke with David Cregeen Saefguarding Lead from RANGE SCHOOL, FORMBY, where AXEL goes to school. He thanked us for the referral and updated me with actions the school have taken. They have searched AXEL'S bag this morning and did not find anything. They have spoken to him about the knife carrying and had broadly the same concerning conversation that police had with him. In addition, it has emerged that when given detention by a teacher last week AXEL was overheard to say "THIS IS WHY TEACHER'S GET MURDERED" - When asked about this he said that it was an off-the-cuff remark but obviously due to carrying a knife and saying he thinks he could use it this is additionally concerning.

		AXEL has been indefinitely excluded from school whilst a conversation is held about his future at the school and Mr. Cregeen is to update me via email once this is known.
