SOUTH CLOSE, OCR, S.39 assault and criminal damage to vehicle

Offender with MH issues (autism) during argument with victim (father) over what was cooked for tea, has kicked Father to leg causing no injury. Offender has then thrown plate at red Ford fiesta [DPA] parked outside on driveway, causing front window screen to crack. Police attended several hours after incident occurred and Axel (suspect) had calmed down. Victim (father) does not want to support a prosecution against son and was after advice and support. Victim is aware that a referral will be submitted and consents for contact to be made. Suspect is already under cams.

Suspect suffers with autism and it is not in public interest to prosecute and victim (father) does not want to make any complaint. Victim has contacted Police for advice, due to struggling with son's behaviour and MH, with referral being made. OIC support victim's decision and offence is low level, no injuries sustained to victim (by being kicked in the leg). No BWV. Victim aware that investigation will be recorded and closed. Victim consents for details to be shared. Golden hour tasks completed.
