Reason for Strategy Discussion		Follow up strategy discussion held. The previous strategy discussion explains the reason for holding the meeting and for having this follow up.

Summary of Information shared by Agencies present		<p>Updates gained from professionals:</p> <p>Children's Social Care: Home visits have taken place to see Axel and Dion. Both children engaged well and the discussions with parents were positive. There is no evidence from a safeguarding point of view of continued risk of harm to the children however there are clearly some outstanding support needs which need to be addressed following assessment and actions from all agencies.</p> <p>CAMHS: Axel has been seen and his presentation is described as very autistic however a diagnosis remains outstanding. It was clear from the appointment that he feels his actions were in retaliation and that he has a sense of injustice about what has happened. Advice was given to parents about having 1-1 time with Axel, discussion took place regarding his feelings towards his brother and that this may help. From the appointment it is not felt that he has any mental health issues and is not experiencing psychosis.</p> <p>Criminal Justice Liaison and Diversion Team: Axel is on the cancellation list for his autism assessment but the best clarity that can be gained at present is that he will be seen this year. He does have a further appointment on 21st Jan with FCAMHS which will focus on his potential risks.</p> <p>Prevent: Axel has been seen by the team and it is not felt that he has any issues regarding the Channel/Prevent programme. there were no concerns that he was being led into criminality or radicalised. It was noted that he showed no remorse for the incident. assessment to be shared.</p> <p>Police: the case remains with the CPS regarding a decision as to whether to charge Axel. his medical records have been requested as part of this decision making process and a request has been made to fast track this.</p> <p>Education: Update provided by Sharon and Pita that the LEA are looking at alternative provision for Axel including a possible 1-1 tutor. A risk assessment is required regarding potential risk to other pupils. A request needs to be made for an EHCP - with parents being identified as best placed to complete this however its also possible for school to do this also. Discussion about a risk assessment needing to be completed prior to Axel's re-introduction to school. There also needs to be a request for statutory assessment and referral to SENDO. CAMHS will provide information to support this request. School will send a letter to parents advising of the steps they will take to provide Axel with education during this process.</p> <p>CSC are completing C&F assessment regarding Axel and Dion and this will comment on the risk he poses and the risks he is subject to. This will need to include information from partner agencies and specifically the appointment with FCAHMS which will comment on the risk he may pose.</p>
