Child(ren)/Young Person's thoughts and feelings	Axel attended the meeting however chose to remain quite. Axel was seen during a recent visit (08/02/22) he reports that the support he is receiving is okay from Carl Coughlin and likes going into the community.
Parent/Carer's thoughts and feelings	Alphonse and Leatisia both reported that Axel enjoys attending the Moels cop youth group but hadn't attended this week as he wasn't ready. They feel that Prestfield is the right direction for Axel's education and that they have had a look around and Axel has made comments that he likes the school and wants to attend. Alphonse queried Axel's dosage of sertraline explaining that Axel won't tell him. Alphonse stated that he should know the dosage as Axel is a minor. He was advised that this cannot be shared because of no consent from Axel and that this would be his decision to share. Alphonse asked about what future support would be offered once CFW step down the case. He was given advice of who he can speak to and to look at the Lancashire website as there is a lot of information what what services are available especially young people with additional needs.
Summary of the progress your family has made, what difference has this made to your child(ren) and what action is now needed over the next 4-6 weeks?	The Early Help plan is progressing. It is positive that Axel is starting to show an interest in community based activities for example the youth group and is engaging with support from relevant agencies. It is also positive that Axel education needs will be met post 16 and that he has been proactive in looking around the school. It is now in my professional opinion that parents need to continue with supporting and encouraging Axel in attending community based activities as this will help build up his confidence and self esteem, it will also hopefully start to build up positive relationships between Axel and his parents. At the next TAF meeting the case will close to CFW as all needs would of been met and a decision made as to who would be lead professional in moving forward under a level 2 service Actions Maggie to make contact with Prestfield school to start looking at the transition process. Parents and Axel to attend Family Therapy via CAMHS Parents to continue to support Axel in attending community based activities.
