Child(ren)/Young Person's thoughts and feelings	Axel not present and due to minimal engagement, voice not gained.
Parent/Carer's thoughts and feelings	Dad states that Axel is okay and he is happy. Dad states that Axel did not attend a appointment with Anthony Molyneux on the 3rd July as he did not want to. Mum and Dad state that Axel has not been taking his medication for some time now due to the side effects that he was experiencing. Dad states that he does encourage Axel but he feels he has demand avoidance disorder which limits what they can push Axel to do. Dad states that he has completed a course at Axel's school to teach him parenting skills for this, however feels he did not learn anything new, and has been using skills such as giving Axel warning, speaking to him as an adult and giving him choice. Dad states they have complete triple P previously and they do not feel that email/calls will work with TYS and Axel. Dad states that Axel likes Mr Bird at school and enjoyed the therapeutic services offered by school and requested more of this. Dad states that if they push Axel too much it can result in a fight, and they wait for moments that Axel wants to engage. Dad states that Axel had got himself ready for school on a strike day and was disappointed that he could not attend. Dad states that Axel has not attended CAHMS. Dad has requested support for demand avoidance.
Summary of the progress your family has made, what difference has this made to your child(ren) and what action is now needed over the next 4-6 weeks?	<p>School update -</p> <ul style="list-style-type: none"> - Axel has not been in school for a significant amount of time. School have arranged for a police safeguarding visit at the family home for 18-07-23 - School advised they can not provide Axel with more therapeutic support than what they already offer due to capacity <p>CFW -</p> <ul style="list-style-type: none"> - TYS has not managed to engage Axel. TYS will sent a letter address to Axel to give him the opportunity to contact TYS on his own behalf. - Due to SFSW being on leave a joint visit has not been possible. Parents are happy to wait, however it is unclear when SFSW will return and so a joint visit may not be possible. - TYS encourages parents to challenge Axel and remove the choices they are giving him, taking back the power dynamic. - CFW offered to make referrals for therapeutic support, however Dad states that Axel does not want therapeutic support outside of school. - CFW will explore parenting support for parents in relation to demand avoidance. <p>CAHMS -</p> <ul style="list-style-type: none"> - No update provided by CAHMS <p>SENDIAS -</p> <ul style="list-style-type: none"> - No update provided by SENDIAS
