Hi Gillian,

Thanks for sharing that information. I was on training yesterday, so unable to respond. Yes we closed the case as all needs were met. This family have had a lot of support from a wide range of services not just recent but in the past. I had a feeling that this would come back in again. Axel is under CAMHS and it was agreed that the support could be supported via the EHCP plan at the closure TAF meeting. The issues are Axel and fathers relationship which is fractious and always will be. Father has completed work on the triple p parenting programme, they are also waiting to attend the riding rapids course and family therapy provided by CAMHS. My professional opinion is father doesn't want to take responsibility for his actions and attitude towards Axel and will often antagonise Axel, which was shown during the last TAF meeting. Father has been given strategies in how to manage Axel. It was agreed at the closure TAF that the family do not meet thresholds for level 3 intensive support. Also to make you aware that Axel has been referred to the transition team. Axel is due to start Presfield specialist High School after the Easter Holidays which I think will elevate some of the tensions within the home.
