Springfield of Burton Limited

On the basis of your recent discussions with Brett Watson, we have agreed to carry specific bladed articles or products (as defined in the Offensive Weapons Act 2019) for you (the "Product"). Our contract is based upon our Standard Terms and Conditions of Carriage ("STCC") which are incorporated into our contract with you.

You have confirmed that the Product types that you would like us to carry are strictly those which were agreed upon the opening of your account. We have approved carriage of these Products only. Any additional Products not approved upon the opening of your account and that you would like us to carry for you would need our approval and must be of a similar nature.

The Products must be packaged as agreed upon your account opening and clearly labelled as containing a bladed Product. You must not make any variation to the agreed packaging without our prior written approval. We reserve the right to review your packaging at any time and may withdraw our approval. Any such approvals or withdrawal of approvals are entirely at our discretion.

You warrant that you will ensure that the Products that we carry for you are compliant with all applicable laws, including but not limited to the Offensive Weapons Act 2019. You also warrant that we are made aware of any consignments containing the Products and they are clearly labelled as containing bladed Products in advance of despatch.

The Products are subject to age verification checks upon delivery. However, you are also required to ensure that there are sufficient age verification checks upon purchase. Upon delivery, we will only deliver parcels containing the Products if the recipient at the address on the parcel label can produce valid proof of identification to evidence that they are aged 18 or over, or where we reasonably believe them to be aged 18 or over. You also warrant to inform consignees that they may be required to produce proof of identification upon delivery. Due to the nature of the goods, you acknowledge that no in flight options via Predict or the DPD App will be available and we can only deliver to the delivery address on the parcel.

In the event that the consignee does not look aged 18 or over and cannot produce valid proof of identification, we will be unable to deliver the parcel and Condition 8(d) of our STCC will apply. Any agreed Service Levels will not be measured against failed deliveries that are due to the recipient's failure to produce valid proof of identification.

In the event that you breach any of the conditions within this letter, and such breach causes us to suffer any liability, loss or damage, you shall indemnify us for such liability, loss and damage. This is in addition to the indemnities provided in Condition 14 of our STCC.
