I am writing to follow up on the data requested pursuant to the s.21 notice sent to our client.

You should by now have received an email from XIUC granting you access to all non-content data responsive to the s.21 notice (I understand that was sent by our client on Friday).

Our client has been diligently working to process your request in compliance with applicable law. However, our client has determined that there is no way it can disclose content data (including the content of direct messages) to the Inquiry via a s.21 notice without violating laws that are applicable to it. In order to provide the Inquiry with content data responsive to its request lawfully, we respectfully ask that the Inquiry applies for an order to obtain the content data pursuant to section 4 of the Crime (Overseas Production Orders) Act 2019 and US/UK CLOUD Act.

Our client immediately provided the Inquiry with all data that it is lawfully permitted to disclose in a timely manner to aid your investigation, and remains committed to resolving the legal obstacles concerning the content data.
