Please find attached details of an urgent CEOP referral in regards to the attached referral from the National Society for the Protection of Cruelty to Children - Childline.

The young person is reported to have said he is being repeatedly bullied at school, -
'There is somebody who I hate in school and I want to kill them.' 'I have took a knife with me to school before but I would only use it if that person really annoyed me in the moment. "When I see this person I want to kill him and I just get more angry when he pushes me and just touches me.'
