I provide this statement in addition to my statement dated 10/09/2024 regarding evidential material identified on electronic devices.

5. Evidential Material on Exhibit SMG2 – Lenovo Tablet

This device is a Lenovo Tab M10 tablet. It was seized from the living room of 10 Old School Close. An extraction from the device was obtained by Digital Forensic Examination.

The device user was listed as 'Megaplasma1' with a last log in date recorded as 23/07/2024 13:28:22 (UTC). The device was in active use between May and July 2024.

In attributing the device to a user, much of the data contained on Exhibit SMG2 mirrors that seen on Exhibit SMG3 (the first Lenovo tablet). For example, the following user accounts were present:

Google - a.hyenadon@gmail.com

Yahoo Mail - a.megalaria7@yahoo.com

These same accounts were present on Exhibit SMG3, upon which fingerprint marks of Axel Rudakubana were found and for which I've previously provided attribution evidence (statement 10/09/2024).

There was also an email present on Exh SMG2 in the inbox of a.megalaria7@yahoo.com which was an e-receipt for the purchase of a Lenovo M10 Tablet dated 09/10/2023. This was from Argos with a billing address of 10 Old School Close, Banks Southport. This is an email address for which Lloyds Bank hold on record for Axel Rudakubana (previously introduced Exhibit AKB/01/01082024 – Lloyds Bank Cover Letter) and 10 Old School Close, Banks is his home address.

The extraction of Exhibit SMG2 has been reviewed and relevant data identified as evidential produced into a report which I now exhibit as:

Exhibit CD/15 – Evidential Data contained on SMG2.

This exhibit contains the data mentioned in the remainder of this statement.

The email account of a.megalaria7@yahoo.com showed numerous emails regarding Amazon deliveries, enquiries with huntingandknives.co.uk, Royal Mail deliveries, knifewarehouse.co.uk, springfields.co.uk, and tacticalarchery.co.uk. Some of these emails show the user contacting these sellers questioning if deliveries are made in plain packaging or not.

Of particular relevance in the 'Trash Folder' of Yahoo Mail were the following emails;

Immediately before these emails are others that show an initial cancelled order from Amazon, again in the 'Trash Folder' of Yahoo Mail;

Previous emails recovered on the device in the Yahoo Mail 'Trash Folder' seem to match an order made with Premier Seeds Direct Ltd placed on 19/01/2022 (Exhibit SM01 – Premier Seeds Invoice) through Amazon costing £9.33. These show the delivery company Hermes delivering an Amazon parcel soon after this order:

24/01/2022 10:39:32 (UTC+0) - Your ^_Amazon^_ parcel is now with your local Hermes courier for delivery

24/01/2022 13:10:00(UTC+0) - Hermes has successfully delivered your ^_Amazon^_ parcel

The extraction of the tablet contained search terms and web bookmarks performed by the user. A list of relevant web history, bookmarks and search terms are included in Exhibit CD/15.

However, the following appears of direct relevance:

At 29/07/2024 10:04:09 (UTC+0) (11:04:09 BST) a user of SMG2 searched Twitter (X) with the term:

"mar mari emmanuel stabbing"

Previously on the same date, a search had been made in the Chrome browser for:

“around 1:22:30 mar mari podcast”

When repeated, these searches quickly lead to press articles regarding the stabbing of Bishop Mar Mari Emmanuel in a Church in Sydney in April 2024. I have repeated the Twitter (X) search for “mar mari emmanuel stabbing” and when performed (on 04/10/2024), navigation via the ‘Media’ tab in X leads to posts containing the actual video footage of Bishop Emmanuel being stabbed whilst live streaming a sermon.

Instagram was installed on the device, with the user account @wasd101123 in use by the user of the tablet. Application usage logs for Instagram recorded the application as being use frequently throughout July 2024 on the tablet. However, no artefacts were found on the device to show a record of viewing Leanne Lucas’ adverts for her Taylor Swift Dance Workshop.

Image 25 on Exh CD/15A (filename 13720.jpg) has an associated timestamp of 29/07/2024 09:06:22 (UTC+0), adjusting this for BST - 10:06:22 BST. It is a screenshot of recent files.

Those accessed in the distant past have a date next to them, for example 5 May 2024.

However, there are five PDF documents with no date, but rather the time “09:51”, signifying they have been accessed shortly before the screenshot was taken and therefore so recent that no date has been placed next to the file name.

These files exist on the tablet as PDF files, and I now introduce these as Exhibits:

CD/15B – Divinity and Experience – The Religion of the Dinka

In a similar fashion to Exhibit SMG3 (the first Lenovo tablet), SMG2 also contained many downloaded PDF documents with file titles suggestive of violence, religions and conflicts. For example:
