As you know Axel is a non attender here at Presfield School. Our headteacher Tony Fay has been in contact with Lancashire authority over this student. We have attempted many home visits unsuccessfully, the last attempt was on 16th Dec 22 and I wanted to let you know we were again unsuccessful.

In Sefton there is a First Day Response team – attendance and welfare department and we have a SEN attendance officer who will conduct home visits upon our request. This is a daily service. I am unaware of any similar service in Lancashire.
